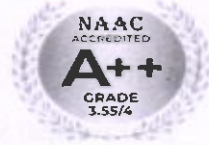

NOTIFICATION

THE GUJARAT PUBLIC UNIVERSITIES ACT NO. 15 of 2023 was assented by Hon'ble Governor of Gujarat and is published in the "Gujarat Government Gazette", on 25th September, 2023. The Act came into force in Universities w.e.f. 9th October, 2023. Dr. Babasaheb Ambedkar Open University has nominated members in the Executive Council vide Notifications issued at Sr. No. (3) above as per the Circular of the Education Department referred above at Sr. No. (1) and KCG's letter referred above at Sr. No. (2).
