• The Dr. Babasaheb Ambedkar Open University (BAOU) was established by the Act No.14 of 1994 passed by the Gujarat State Legislature, and assented to by The Governor of Gujarat on 27th July, 1994. The BAOU is the seventh Open University in the country in terms of their establishment.

The headquarters of the university is located at Ahmedabad. The University has more than 250 active study centers and three regional Centres located at Rajkot, Bhuj and Surat. The university offers 83 courses which include various certificate, diploma, post-graduate diploma, degree, post-graduate degree, M.Phil and Ph.D. courses and has average enrolment of 70,000 students per year. The jurisdiction of the university comprises of the whole state of Gujarat. It is open to all persons irrespective of classes, castes, creed, religion or gender.

The important and distinguishing objectives of the university are to advance and disseminate learning and knowledge by a diversity of means, including use of any communication technology, provide opportunities for higher education to a large segment of the population, promote the educational well-being of the community generally and encourage the Open University and distance education system in the education pattern of the State

Garbhopnishad Foundation (Formly Garbh Vigyan Anusandhan Kendra, estd. 2003) was established with the objectives to guide, help and assist mainly women and children in their well being and cure of diseases through Ayurveda clinics, hospitals, healthcare centres and centres for Panchakarm, yog & natural therapy.

To provide a platform for best progeny couples by giving them ser-vices for pre conception, antenatal and postnatal health.

To carry out activities of research related to pregnancy & diseases related to women and children, work for providing medical & healthcare services to the society

To impart training to health workers, doctors and medical students etc. for prevention and cure of disease of mainly women and children.

To plan, organize, equip, conduct, develop, improve. administer and review projects and programmes for preventive and curative healthcare for Sustainable development of healthy lifestyle in general.

OBJECTIVES of MOU The Dr. BABASAHEB AMBEDKAR OPEN UNIVERSITY wishes to forge Knowledge Partnership in the area of Garbhsanskar to support in spreading awareness about Garbhsanskar, providing more and better opportunities of learning for those who wish to learn about Garbhsanskar, knowledge sharing, publication — related Garbh sanskar, research and academic development. The Dr. Babasaheb Ambedkar Open University would take academic help from the Garbhopnishad Foundation and jointly organise Seminar, Conferences, Symposium, Prashikshan Shibirs (Camps for doctorss' Training, Yog Consultants and Social Workers in the field of health.

WHEREAS Under this Agreement, as a knowledge partner this MOU shall be valid for THREE years from the date of its execution. However, agreements concluded under this MOU shall be valid till end of contracting obligations and responsibilities of the concerned parties. The validity of this MOU can be further extended with mutual consent of the parties in writing.

Termination This MOU can be terminated by either of the parties by giving three months' notice in writing without assigning any reason thereof, subject to completion of assignments in hand.
